



Article 33 Declaration of the REACH Regulation 1907/2006/EC - Articles

Based on the Candidate List of SVHC from 2025.06.25

The European Regulation 1907/2006/EC, is covering the registration, evaluation, authorisation, and restriction of chemical substances (REACH) entered into force on June 1st, 2007. In accordance with article 33 of the REACH regulation, W&H Dentalwerk Bürmoos GmbH, Ignaz-Glaser-Straße 53, A-5111 Bürmoos, Austria, is required to inform the recipient of an article if any component exceeding 0.1% (weight by weight) of a SVHC substance. With this declaration, W&H complies with this information obligation.

W&H Dentalwerk Bürmoos GmbH has integrated a comprehensive material compliance process. A permanent reviewing of our supplier data and the current SVHC list is part of this process. Furthermore, we try to substitute SVHC substances as far as possible.
